Small Group Calls on State Experiences with D-SNP Information Sharing

As of January 1, 2021, Dual Eligible Special Needs Plans (D-SNPs) were required to begin sharing information with the state or the state's designees on hospital and skilled nursing facility admissions for one group of high-risk enrollees. Over the last two years, the Integrated Care Resource Center (ICRC) and the Medicare-Medicaid Coordination Office (MMCO) have supported states as they developed information-sharing process. In May, ICRC will hold a series of small group calls for state Medicaid agencies focused on specific approaches or aspects of D-SNP information sharing.

We realize that states are just beginning these efforts and that the care coordination activities triggered in response to hospital and SNF admissions notifications will continue to develop and evolve over time. Nevertheless, we want to provide an opportunity for states to share their early experiences and learn from one another. Both ICRC and MMCO staff will also be available to respond to your questions on these calls.

Please consider registering to attend one or more of these three calls, the agendas for which were determined via previous responses to a single survey question used to help identify states' priorities for discussion topics on D-SNP information-sharing for each call.

Participation in these calls is limited to state or designee state staff, so while you should feel free to pass this invitation along to colleagues with other state agencies that are recipients of admissions information. please do not invite D-SNP or Medicaid MCO staff.
